 My husband , late Sh. Suraj Prasad (the last designation held was Sr.AGM , staff no : 268577 88001181) .
 Sir his sudden on duty death in July 2020 has left us without any support and in a lot of adversities as he was the sole earning member in the family .
 We forwarded our application request back in July 2020 , requesting the concerned authorities to release his PF , gratuity and other funds , final settlement of his accounts at the office , and humbly prayed to them to please release the ad-hoc compensation payment as well .

But despite a crystal clear nomination filed by my late husband the concerned authorities have not yet settled his accounts and have not even given us the ad hoc compensation payment , as my late husband was the sole earning member in the family , since his on duty death in July 2020 , I had to take a lot of debts in which Iam trapped at the moment which is challenging the very survival of me and my children . And the primary reason for such an exacerbation to my adversities was the unnecessary delay caused by the concerned authorities even after they have the clear nomination papers filed in the office records .

And hence my application request through this RTI application is :

- 1) may I please know that what is causing so much of a delay on the concerned officials part .
- 2) the usual time the concerned department of Air India takes while settling the accounts of a deceased employee who died on duty and has left a clear nomination papers .
